JANUARY 2007 AIRLINE PASSENGER OPERATING STATISTICS

Passenger numbers for the month increased by 12.11% over the previous year. Skywest traffic, measured by Revenue Passenger Kilometres ("RPKs") increased by 9.02%, while capacity, measured by Available Seat Kilometres ("ASKs") increased by 1.23% over the same period. Load Factor increased by 3.84% to 53.75% compared to the previous year.
